## How to support LGBTQI+ employees in the workplace

Amongst any group of people, there will be a range of sexualities and genders. This variation is often depicted using the image of a rainbow to demonstrate that sexual orientation and gender identity can be more than one or other type. Our training session considers how to create a positive work environment, where difference is understood and respected by touching on the subject from a common humanity perspective. The session is interactive and covers a wide range of topics over one hour.

Participants will:

- Learn the difference between sexual orientation, gender identity and gender expression
- Understand LGBTQI+ terminology
- Explore how different cultures approach this topic
- Practise how to start a conversation with someone in the LGBTQI+ community in a way that is respectful and use their preferred pronouns
- Learn how to be an ally in the workplace
- · Know how to deal with issues of disrespect or safeguarding in the workplace
